Iris Inspires Sweepstakes

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. ELIGIBILITY; METHOD TO ENTER; SUBMISSION GUIDELINES.

The Iris Inspires Sweepstakes (the "Sweepstakes") is offered to legal U.S. residents at least 18 years old who, as of the start date, are qualified pre-registered attendees for the NY NOW 2018 Summer Market (as that term is defined on the attendee registration page at NYNOW.COM) in New York City opening August 12, 2018 and who leading up to the market dates post pictures showcasing something from their stores, or from their own designs that is inspired by Iris Apfel (person) on Instagram using hashtags #IrisInspires #nynow, and #sweepstakes (the "Entry"). To be eligible to win and claim a prize, the entrant must be a qualified pre-registered attendee, and must attend the market to claim the prize. No entry fee, payment, or proof of purchase is required to enter the Sweepstakes.
